Additionally, a motion to approve South Chicago Parents and Friends, Inc., as the 2020 Service Provider Agency was made by Bonnie Dinell-Dimond, seconded by Alex J. Alemis. Motion carried.

#### 3. Items for Discussion

A request by Justin Jordan, business owner for a blanket letter of support from the SSA 5 commissioners was revisited. After a discussion, it was agreed that each event he hosts, he can request a support letter if it aligns with the goals of the community and SSA 5. Also, Mr. Jordan will be invited to join the event committee of the SSA 5.

Dave price discussed the possibility of teaming with a non-profit agency called Resurrection Project to clean lots that are in need of clearing and cleaning.

Dave Price said he is meeting with the individuals form the 10<sup>th</sup> Ward Alderwoman's office, Danielle, and the 4<sup>th</sup> District Police Commander to discuss the future planned events for the SSA 5.
